 - a) To prepare and submit a Traffic Management Plan (TMP) for approval, ensuring compliance with relevant guidelines.
 - b) To conduct retro-reflectivity testing on road markings along the PLUS Highway mainline using **mobile retro-reflectometers**.
 - c) To record readings and identify faded markings based on MHA criteria (minimum 150 mcd/lux/m² or 50% wear).
 - d) To provide strip maps and submit reports in both hard and electronic copies.

Tenderers are not allowed to change the joint venture/consortium company after the tender closing date
