**PROPOSED RETRO REFLECTIVITY TESTING FOR MAINLINE SIGNAGES ALONG NORTHERN, CENTRAL AND SOUTHERN REGION OF PLUS HIGHWAY FOR YEAR**

Projek Lebuhraya Usahasama Berhad ("PLUS Berhad") would like to invite qualified contractors to partake in the Tender based on the conditions below:

- 1) Company registered with Suruhanjaya Syarikat Malaysia (SSM)
- 2) Company registered with Construction Industry Development Board Malaysia (CIDB) with **Grade G3** and above with minimum CIDB star rating of **3 stars** and specialization as follows :-
  - a. **CE21 – Civil Engineering Construction**
  - b. **CE43 – Road Furniture**
- 3) Company with experienced in road furniture - Road Marking Testing work for the past 5 years with a project value minimum RM1.0 million and above in a single contract.
- 4) The brief scope of works are as follows :-
  - a) To inspect and measure the retroreflection or brightness level of the retroreflective material use for the traffic signing by conducting retro reflectivity testing on existing mainline signage at locations in accordance with ASTM D4956 as directed by Employer's Representative.
  - b) The location of testing is along North - South Expressway for mainline only and involving directional sign, butterfly and cantilever gantry sign.
  - c) The contractor shall provide the readings and data per PLUS's requirements and submit a strip map based on site data collection.
  - d) The duration of contract is within six month from the date of commencement for all three region.

Tenderers are not allowed to change the joint venture/consortium company after the tender closing date
