4) The brief scope of works as follows:

- a. To construct covered parking at two toll plaza locations, refuse chamber at two laybys, construct steel post at sharp edge to fascia panel at walkway toll plaza and extension of walkway roof at foodcourt.
- b. To carry out replacement work of gutter and rainwater downpipe inclusive applying waterproofing membrane and laying of 100mm UPVC pipe.
- c. To carry out cleaning of metal deck roof and nosing at toll canopy and repainting work of metal deck roof and faded pascia panel.
- d. To carry out replacement work of damaged fascia panel, damaged floor tiles, damaged ceiling and installation of timber panel at identified location.
- e. To include any other items/work relevant and required for the completion of the works such as site clearance, earthwork, relocation and realignment of affected services, landscaping and etc.
