QUALIFICATION REQUIREMENTS

- Tenderers who are interested to participate in this tender must have experience as a main design and supervision consultant for a project worth no less than **RM1 billion within the past 15 years** in the appointment of contract for the following works:
 - Construction of new highways or highways widening for highway concessionaires in Malaysia; and
 - Construction of elevated highways and bridges in Malaysia.
- Average company annual revenue over the past 3 years of equal to or more than RM50 million.
- The tenderer is allowed to submit only one (1) tender. Any tenderer found to have submitted more than one (1) tender will have their entire participation to be automatically disqualified.
- Tender Deposit amounting to **Ringgit Malaysia: Ten Thousand Only (RM10,000.00)** in the form of a bank draft from a licensed bank operating in Malaysia under the name **"PROJEK LEBUHRAYA USAHASAMA BERHAD"** along with the Tender Document to be submitted on or before the Tender Closing Date and Time.
